for the committee to accomplish in 2018. The VNNC also to consider giving each committee a budget of \$1000 for operating expenses and whatnot. (NTE \$6000)

c. The Van Nuys Neighborhood Council to partner with the Office of Assemblymember Adrin Nazarian for the annual job fair expo. The VNNC to assist greeting and signing in applicants, as well as offer support and staffing for the event and the Assemblymember. The VNNC to feed approximately 60 individuals with \$1000 from the VNNC general fund. Funding and Action Item. NTE \$1000.

d. The VNNC to host a “Taste Of Van Nuys” at it’s December General Meeting. The VNNC to pick 3-5 ethnically diverse restaurants to sample the delicious dishes from the businesses that make up the community of Van Nuys. The VNNC to continue to reach out to different restaurants and businesses in Van Nuys to continue the “Taste Of Van Nuys” at least once a quarter year. This item to also be referred to the Budget Committee. (NTE \$500)

e. The VNNC to partner with the Los Angeles Public Library and the Children’s and Teen Librarians for possible proposals to use government funds for the benefit of our community. The VNNC to formally discuss what is required to seek approval of these funds for the Van Nuys Library so the Librarians can begin to write proposals. (NTE \$4000)

f. The VNNC to vote on and take action on filling the two vacant council seats currently on the roster. The VNNC to consider all candidates willing to undergo the arduous process of becoming a Councilmember. The VNNC to also consider making the seats an “At-Large” designation until the end of the term of the seat, as to make it easier to fill for those that seek to represent their community.

g. The VNNC to feature State Senator Bob Hertzberg in it’s ongoing “Distinguished Speaker Series.” The Senator will address the Council for 15 minutes, with a question and answer session to follow up the speech. The VNNC will also take 5 minutes to brain storm with the Senator and come up with four new ways to collaborate with his office in 2018. Funding for the collaborations shall not exceed \$4000. This item to be referred to the Budget Committee. (NTE \$4000)

h. The VNNC to discuss funding for office space off of Van Nuys Blvd and Gilmore Avenue. The VNNC to consider entering into a lease agreement with “Executive Office Suites” to have an ongoing government office Councilmembers and constituents can access to address the concerns of the community. The VNNC to hear full proposal from VP Howard Benjamin. This item to be referred to the Budget Committee. (NTE \$1000 a month)

i. The VNNC Executive Committee to adopt all actions taken by the PLUM Committee at it’s informational meeting in November. The VNNC Executive Committee to formally discuss possible Brown Act violations and how to address grievances that may or may not arise depending on certain circumstances.
