Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Board meeting. Public comment is limited to 2 minute per speaker, per item, with a maximum total of 10 minutes per speaker, unless adjusted by the Council President and/or facilitator.

1. Call to Order, Pledge of Allegiance to the United States of America and Roll Call

- a. The VNNC to support and assist Los Angeles City Councilman David Ryu and his “Senior Scam Stopper” event on March 21st. Moreover, the VNNC to staff and help Councilman Ryu with all aspects of this important event. Additionally, the VNNC to consider funding a future Neighborhood Purposes Grant (NPG) for the Valley Interfaith Alliance which is co-sponsoring this event. NTE \$500.
- b. The VNNC to support the government program known as ARM, or the Asteroid Realignment Mission. Moreover, the VNNC to request additional funding from the Federal Government for this program, as well as STEM (Science, Technology, Engineering and Math) education in all of our schools in Van Nuys. Additionally, the VNNC to host an interplanetary defense initiative town hall with the Jet Propulsion Lab (JPL) and the National Aeronautics and Space Administration (NASA). The VNNC to also reach out to our local San Fernando Valley Congressman Brad Sherman for assistance, as Mr. Sherman is a senior ranking member of the Science Committee in the House of Representatives. Moreover, the VNNC to file a Community Impact Statement (CIS) & Call To Action (CTA) requesting NASA and all our governments dedicated to space clean up the Santa Susanna Field Lab and make it the mission to fund and address the need to support the government program known as ARM.
