Background: On July 14th, the VNNC Board approved the VNNC FY 2021-2022 budget for \$32,000 -- the amount of new funds allocated to the VNNC by the City for the new fiscal year. On August 2, the VNNC was notified by the Office of the City Clerk, Neighborhood Council Funding Program that \$10,000 in unspent funds from the VNNC FY 2020-2021 budget was available to be "rolled over" into the VNNC 2021-2022. The Clerk's office indicated that the VNNC needs to approve a revised budget that reflects total funds of \$42,000. Consistent with the notes on the budget approved on July 14th, the Budget and Finance Committee recommends that the \$10,000 in rollover funds be added to the budget category for Neighborhood Purpose Grants. This will bring the total amount of funds available for Neighborhood Purpose Grants to \$14,000.
