 - a. Featured Presentation (10 min.): Melinda Gejer, Public Policy Coordinator, StreetsLA, Department of Public Works, City of Los Angeles. She will be making a presentation on the Van Nuys tree inventory report and identify areas where more trees could be added https://vnnc.org/ wp-content/uploads/2021/10/Van-Nuys tree-inventory-report-summary.pdf In addition, Steven Dupre, Urban Forestry, City of LA. City has aerial photo study of trees—especially for "right of way" plantings. There are 26% vacancies in possible City tree wells in City ROW. An analysis of City trees finds 52% broadleaf, 26% conifer. Most popular others—Mexican fan palm, liquid amber, crepe myrtle, magnolia, queen palms. <u>CityPlants.org</u> helps provide trees to the public as a public service. Renters would need to get property owner approval before tree(s) could be planted.
 - LAPD Van Nuys Division-Officer. Perez. Trunk or Treat: on Oct 23 at 3-5 pm. New SLO. Officer Gutierrez, s of Victory down to Magnolia, and between Hazeltine/Cedros and Sepulvea.
 - c. Department of Neighborhood Empowerment (DONE) Lorenzo Briceno. "Planning 101" is now ready for PLUM members to take. Additions to proposed Code of Conduct—4 planned sessions were on line—last is Sat, Nov 6, 1-3 pm. "Meetings" remain "virtual" on a month-to-month consideration.
 - d. Board of Supervisors—Los Angeles County 3rd District Sheila Kuehl by Brenda Yanez. (818) 901-3831 County will help give "Covid 3rd shot", Check at "my turn.ca.gov. Invite people to discussions on disposition of Whiteman Airpark (San Fernando Rd., Pacoima) by the Whitemen Airport Community Advisory Panel Thurs, Oct 28 virtually.
 - e. Council District 2 Karo Torosian for Krekorian— (818) 213-5640. Spoke about identifying sites under City Ordinance re M.C. 41-18 where homeless may <u>not</u> camp. CD 2 has designated two areas in Van Nuys: 1000 feet from "A Bridge Home" site at Amtrak station on Van Nuys Blvd. and 500 ft. around Van Nuys Elementary School.
 - f. Senate District 18 Edwin Amaya—(edwin.amaya@sen.ca.gov) Sen. Hertzberg had 100% of his offered legislation signed into law. Highlighted two bills: SB 267 re clean up legislation on solar tax breaks and SB 539 re senior property tax issues in Proposition 19. Time for LAUSD parents to exercise their choice option with regard to enrollment in special programs, such as magnet schools, dual-language programs, etc.

- g. Council District 6 Marcos Sanchez— (marcos.sanchez@lacity.org) VN Public Library reopened after 2 years. Councilwoman Martinez announced that a monument for former Supreme Court Justice Ruth Bader Ginsburg has been conceived (wit funds donated by Hulu) to be installed where pergola previously stood next to library and in front of Van Nuys Superior Courthouse. Food drive Oct 15 for 500-750 families. Covid 19 shots remain available at Mid Valley YMCA.
- h. Cal Congressional District 29 (Cardenas). Osvaldo Ramirez. New budget under negotiation in Congress includes \$12.5 million specifically targeted for the Valley. If people have Issues with receiving new "Child care funding credits," they can contact office for help.

<u>for-consideration-.pdf</u> Every 10 years, after the Census, an appointed City committee works to create boundaries for equal and similar Councilmanic districts meets. One goal was to have five full districts in the Valley—and only 1 district (vs. current 2 districts) to span the Santa Monica Mountains. Are paying attention to trying to keep the boundaries of individual neighborhood councila within one Council district. Very concerned that on the latest proposed map, the Van Nuys NC area Is arbitratily split into east and west areas along a street roughly two blocks west Van Nuys BI. A large chunk of Van Nuys from Van Nuys BL westward is awarded to a Lake Balboa—Reseda centered seat. Community concern over "splitting Van Nuys". Marcos Sanchez from Martinez's office suggested that VNNC ought to claim the Sepulveda Basin Recreation Area and Van Nuys Airport. Need a CIS to present to Saturday's LA City Council Redistricting Commission hearing— expressing our concern about splitting Van Nuys down Van Nuys BL (approx.) and to guarantee "speaking time" at hearing. VP Schreiner will speak. City Council is "final arbiter" on where the lines will be drawn.
