NC Funding Representative: VNNC can vet different companies/vendors that provide such services i.e graphic design, logo and printing. Please keep in mind that a contract would have to be drafted by our office. NC Contracts a. Expenditures will require a contract if the expenditure falls under one of the criteria listed below: i. Owner of the location/business requires a contract ii. Expenditure for the service exceeds \$5,000 within a fiscal year iii. Expenditure for the service exceeds three months (exceptions may include subscription services) iv. The risk and liability exposure to the City, as determined by the NC Funding Program, is excessive I'm also including our link to our Policies and Guidelines here for your convenience and reference. Page 37 covers in detail NC Contracts. It might require a contract depending on the scope of service and vendor's needs. We also review the vetted vendor for any risk and liability to the City. Once VNNC has decided on a vendor for such services, we would review if a contract is needed. In addition, if VNNC is having their NC logo re-designed (as an example), an Assignment of Rights agreement must be executed. Once the VNNC has vetted the vendor and approves the project, we can provide additional advice as to what may be needed and required. In addition, I would recommend for VNNC to vet vendors that can provide the following (In the event that a contract is needed).

- 2. Vendor's Certificate of Insurance
- 3. Vendor's Business Tax Registration Certificate
- 4. Vendor's scope of work/invoice
