PUBLIC INPUT AT NEIGHBORHOOD COUNCIL MEETINGS The public is requested to dial *9 if participating by phone or "Raise Hand" if participating by computer, when prompted by the presiding officer, to address the Board on any agenda item before the Board takes an action on an item. Comments from the public on agenda items will be heard only when the respective item is being considered. Comments from the public on other matters not appearing on the agenda that are within the Board's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Board meeting. 4. **Discussion and Possible Action:** Draft Van Nuys Neighborhood Council proposes the Los Angeles City Council pass an ordinance requiring any apartment building of eighteen (18) units or more, have an owner or manager be in living residence on the premises. Consideration too that an apartment owner may not evict any tenant over 65 years of age or receiving federal or state disability, and that the manager must have a reasonable method of entry into each unit, such as a unit entry key, on the premises. We ask the Los Angeles City Council to provide a time limit for the property owner to meet this requirement, along with tenant eviction compensation, if necessary.
