Background: The ballot measure will require the City of Los Angeles to implement its Mobility Plan 2035 whenever the City repaves or otherwise works on a street. The Mobility Plan 2035 calls for the construction of a connected network of pedestrian and bicycle routes, transit routes, and vehicle routes with the goal of creating a complete street network to support streets as public places for the safe utilization for all modes of transportation. Implementation of the ballot measure is expected to save money, reduce traffic, make the streets safer, and give people more options to get around town, while helping to clean the air. - i. **Discussion and Possible Actions to urge the City of Los Angeles to offer** Home Boy Industries all the City assistance possible to consider a bakery—coffee shop next door to the BRAUDE public meeting room at 6262 Van Nuys Bl in the commercial spaces available.
- ii. **Discussion about the old Van Nuys Post Office** (VN Bl at Delano) that is owned by CB Richard Ellis (Senator Feinstein's late husband) and possible uses.
- iii. **Discussion** about the "Sherman Circle"—what it was—City's indifference to do more for a resource it owns—and how City could make a "pocket park" out of it. The 1911 cross Valley "grand Sherman Way tree planting"

- iv. CITY has already designated 1200 "cultural historical landmarks since the 1960's. CITY is considering a "historical QC marker project". There's room for discussion. Both well Ranch—5300 Oakdale, South of Ventura Bl at Corbin, in Tarzana, is of interest to Councilman Blumenfeld as parkland, and last remnant of the 1920's "Orange Empire" that Southern California and Valley was. (Nearest example of this "Orange Empire" in CA history, is a Cal state park in Riverside.)

Both are WPA designed and influenced buildings.

- vii. This "Welcome to Van Nuys" tombstone placed in the 1970's—where Chandler Bl runs into Van Nuys Bl—south of Burbank. Our "tombstone"—put up by Van Nuys Chamber of Commerce (I'm told). And very much a tombstone. Even the Chamber left town—centering around Van Nuys Airport. Reseda's done better—North Hollywood has a Lankershim Bl arch, Encino a Ventura Bl arch—and Chinatown has an arch too. Motion is to talk to Chamber, City, to discuss exchanging the "Chandler—Van Nuys marker" with something more modern.
