 - Background: The Van Nuys Airport is planning to expand, but has not taken adequate steps to consult with the community. At a meeting of the airport's Citizens Advisory Committee on 9/5 over 100 citizens attended, and many expressed concerns about current impacts of the airport on their lives and questioned whether expansion would lead to more negative impacts.
- **14.** Discussion and possible action to submit a CIS to the City Council and the City Planning Commission on Council File 22-0392 to express opposition to the City authorizing Metro to erect two large digital billboards on Metro property near the G Line (Orange Line) at Van Nuys Blvd. and Sepulveda Blvd.

Background: At the direction of the Los Angeles City Council, Los Angeles City Planning has prepared two ordinances to amend the Zoning Code to allow the Los Angeles County Metropolitan Transportation Authority (Metro) to implement a Transit Communication Network (TCN) (CF 22-0392).

Metro is proposing to erect digital display signs on up to 49 Metro-owned parcels throughout the city that are adjacent to certain freeways and major streets as part of its TCN program. The proposed ordinances, known collectively as the Metro TCN ordinance, will create a new Supplemental Use District (SUD) and include a Zone Change to apply the TCN SUD and its regulations to specific parcels owned by Metro.

Position taken by Sherman Oaks Neighborhood Council:

The Sherman Oaks Neighborhood Council at its July 10, 2023 meeting adopted a position of Against regarding City Council File 22-0392. The proposed Transportation Communication Network (TCN) (Council File 22-0392) ordinance will allow Metro to erect up to 86 digital billboards on Metro owned property, approximately 50-foot long electronic, moving image billboards with up to 51,000 square feet of display area with an estimated income of \$15 million to \$25 million per year that will be split evenly with Metro and the City of Los Angeles (Metro's annual budget is \$9 billion dollars, LA City's budget is \$43 billion).

These billboards will be along freeways and surface streets. For little financial gain from the TNC, the citizens will suffer unnecessary visual blight and unsafe driver distraction. Therefore, the Sherman Oaks Neighborhood Council strongly opposes the LA City Planning Department's ordinance to amend the Los Angeles Municipal Code to allow Metro to implement a Transportation Communication Network (TCN) (CF 22-0392).

Excerpt from Section on Committees from VNNC Bylaws

Article VII COMMITTEES AND THEIR DUTIES

Section 3: Committee Creation and Authorization

- A. **Committee Authority** All Committee recommendations shall be brought back to the full Board for discussion and action. Committees shall not represent an official Board position without prior Council approval.
- B. **Committee Structure** With the exception of Executive Committee, all Standing Committees shall be comprised of at least three (3) Directors but no more than five (5) Directors and may include any interested Stakeholders. Each Director is required to be an active participating member of at least one (1) Standing Committee.
- C. **Committee Appointment** The Board will select its Committee Chairs annually by simple majority vote by the Board members present at the General Board meeting. The selection of Committee Chairs will take place in July of each year.
 - i. If there are more than two (2) candidates and none receives a majority vote, a run-off vote by the Board shall be held immediately between the two (2) candidates receiving the highest number of votes.
 - 2. In the event of a vacancy, a new Chair will be selected by the Board by simple majority vote of the Directors present at a Board meeting. Upon termination of Committee Chair(s), all official records of the Committee will be surrendered to the Executive Committee within 30 days.
 - 3. Committee members shall be appointed by the Committee Chair, subject to confirmation by the Committee itself. Stakeholders may become voting members of a Standing Committee, except for Executive Committee.
 - 4. All committee members must complete ethics and funding training prior to voting.
- D. Committee Meetings Committee meetings are subject to and shall be conducted in accordance with the dictates of the Brown Act. The Chair shall (or designate a Committee member) to keep a written record of Committee meetings and provide regular reports on Committee matters to the Council. Minutes shall be taken at every Standing Committee meeting and forwarded to a Director in a timely manner.
- E. **Changes to Committees** The Board may establish, disband or make changes as needed to any Committee by a simple majority vote of Board members present. Any such action by the Board shall be noted in the Board meeting minutes.
- F. **Removal of Committee Chairs** Committee Chairs serve at the pleasure of the Board and may be removed by a 2/3 majority of Board members present.

All committee work is to be reported to the Board and no actions can be taken on behalf of the VNNC without a vote by the Board.
