#### Hi Ms. Kathy,

I finally got all the follow-ups to the questions you all had at the committee meeting last week.

- We went ahead and forwarded your email about civic education to the Van Nuys High School principal, you should be hearing back from the school shortly.
- We also asked the head Food Services Division Mr. Manish about providing school lunches while students are on break and this was his response:

"Federal regulations no longer permit us to serve meals when schools are not in session. On the other hand, USDA is still issuing P-EBT cards, and till the time these cards are available, families that qualify will be able to get funds for students when schools are not in session.

Please note that the cards are customarily issued some months after the break. For e.g., cards for summer will probably be issued in November. (LAUSD is not responsible for card distribution, which is in the hands of USDA and distributed by CDE."
