9. Proposed CIS Recommended by Education Committee and Parks, Open Space, and Environment Committee

a. Discussion and possible action to approve submission of a Community Impact Statement (CIS) to the Board of Recreation and Parks Commissioners to recommend that priority be given to SFV LAUSD Middle Schools for implementation of the next phase of the Department of Recreation and Parks "Community School Park" program – a program that will make school grounds available on weekends, holidays, and summer for community use for structured recreational activities. Also submit a CIS to LAUSD Board of Education to make the same recommendation – i.e., to advocate for priority to be given to SFV middle schools in the next phase of the "Community School Park" program. Since Van Nuys has little open space to develop new parks, having LAUSD schools in our area designated as Community School Parks would mean that the Department of Recreation and Parks would staff the school grounds during non-school hours (i.e., on weekends, holidays, and summer) so that the fields and play areas could be used by the community for recreational activities. The Community School Parks had a pilot implementation at four schools in April 2018. A new phase of the program was planned to start in fall of 2022, and five middle schools were selected for implementation of Community School Parks. All five schools are located in Council Districts 8, 9, and 10 -- even though schools in the SFV had a higher potential number of people who could be impacted than four of the chosen schools. It is proposed that the VNNC advocate that when Recreation and Parks chooses schools for the next phase of the program, they give priority to middle schools in the San Fernando Valley in areas that are ranked as having a high need for

parks.
