LAPD Van Nuys Division <u>https://vnnc.org/resource/</u> Senior Lead Officer (SLO)George Lara <u>38454@lapd.online</u> 818-731-2557 Basic Car 9A23 reported that property crime and violent crime is down. Many of the crimes are committed by the homeless and are retail theft. SLO Lara provided maps of the area and contact information for LAPD. Van Nuys is down to two SLOs for the area for the next couple of months.
- b. Council District 2 –Cairo Rodríguez <u>cairo.rodriguez@lacity.org</u> 818-755-7676 Lorraine Diaz was in attendance for Cairo Rodriguez and reported that she is in charge of homelessness for CD 2. Currently the Van Nuys bridge housing is filled to compacity. There were a few female beds, but due to the weather those beds have filled. There are four other sites in CD2 that have capacity so if you know someone that is experiencing homelessness, let us know and we will refer them to interim housing. LAPD has been a big help in helping the homeless get housing. Currently 18 homeless have been housed through LAPD. CD 2 is currently accepting applications for the youth leadership academy this summer. It is a two week program for four hours a day to teach high school students about government. The students work in the office and

  - a. Richard Marks reviewed the experience he had on the streets with people about the Neighborhood Councils. No one knows we are here. No one is in the audience and when we were on Zoom, we had no one in the audience. We have no say what goes on in Van Nuys. Richard Marks asked who would spend one hour a month to go on the streets and outreach to the community. When we see a hundred people in the audience, we would have done our jobs. We need to get more people involved and fill this meeting. Only then, we will have power.
  - b. Michael Browning stated that we almost have no power. We have done great work. We only make recommendations. Why go to the middleman when stakeholders can go to the man when it comes to PLUM or any other decisions.
  - c. Brian Edelman stated the importance of Neighborhood Councils. He spent three years coming to meetings and lost two elections, but kept coming. You need to find a place to go and this is the place to start. Have not seen good options to get people to the meetings. What can we do to help out. Find a way to let people know that we are here and that people can come to us.
  - d. David Harari 60% of Van Nuys is Spanish and we need to push DONE and the City Council to have translation. We should always be asking for translation services. Understands that translation needs to come out of the budget of the Neighborhood Council and that it can put a burden on the VNNC. It should not come out of the VNNC budget and we should always be asking when there will be a

budget for translation. We need to hammer DONE every time they are here.

- e. Kathy Schreiner has written emails to DONE requesting translations and how DONE can support us.
- f. Jennifer Febre stated that everyone needs to know what the VNNC can do. We have one mandate to make recommendations and have a limited scope. Funds to nonprofits and schools. How do you get people involve? Nothing of interest for people to come. Very limited power. We have a very small email list with mainly government officials. Using social media and Instagram is an illusion.
- g. Kathy Schreiner thinks that we can do better to get people to the meetings. We need to find out what people want.

Each Neighborhood Council should also name its own DWP Representative (who does not necessarily need to be a Board member), along with an Alternate Representative. The NC can choose the way to name a representative (e.g., by Board action or by appointment by the President or by the executive committee).
