#### Committees

Committees may not take any final actions. The presents recommendations to the Board for final action.

#### The Brown Act

• California's first sunshine law, enacted in 1953.

#### • The Brown Act = Transparency

The Brown Act is a California state law governing open meetings for local governmental bodies. It establishes rules to ensure that:

- ✓ actions and deliberations of commissions, boards, councils and other public bodies of local agencies are taken openly
- ✓ public have access to the meeting and its agenda
- ✓ public has the opportunity to provide input.

The Brown Act ensures Transparency and Public Participation in Local Government

### Agendas are part of Transparency

- Importance of Agendas
  - ✓ The Agenda will help the Public to make an informed decision whether to attend the meeting or not.
  - ✓ The agenda provides structure to a meeting.
- Requirements for Agendas
  - ✓ The agenda must list all items that will be discussed or acted upon.
  - ✓ Items should be described in an informative way so that the Public as well as board members understand the general nature of each item. The goal of the description is to provide a reasonably clear understanding of what is to be considered by the board at its meeting.
  - ✓ Include required language prescribed by DONE. Example of a well-written agenda item:

Discussion and possible motion to approve up to \$1,500.00 to Carecen as a community partner for their Annual Holiday Posada community event.

Event participation will include tabling, NC listing on all event promo material and sharing of community contact information.

Event is scheduled for December 2019.

- Posting of agendas at least 72 hours before a meeting
  - ✓ Submitted to NC Support (DONE) for posting to the Early Notification System
  - ✓ Posted to the vnnc.org website

✓ Physical copy posted at the front of the Braude Center

## Discuss issues and make decisions in public meetings.

How can the VNNC influence the City of Los Angeles?

- Submit a Community Impact Statement (CIS) to indicate support or opposition to a Council Motion (with a Council File Number)
   May also submit a CIS to a City Board or Commission (e.g., City Planning Commission, Recreation and Parks Commission, etc.)
- Advocate to local Council Offices for improvements in services and public facilities.
- Join coalitions that can increase our "voice."

Use VNNC funds to support community organizations and community beautification projects
