## 2. Reports from Government officials:

- a. LAPD Van Nuys Division <a href="https://vnnc.org/resource/">https://vnnc.org/resource/</a> SLO Perez reported that some of the officers are out on leave, but all requests will be answered. SLO Perez handed out the Van Nuys Basic Car map that includes the SLOs' contact information. The top intersections for traffic collisions are Sherman Way and Woodman, Bolton and Victory, Ranchito and Victory, and Saticoy and Van Nuys. There were 85 collisions for the first six months of this year. Twenty of those collisions were serious and four (4) resulted in death and 61 were DUI related. So, if you are out at night, be careful about your surroundings.
- b. LAFD Deputy Chief Conroy reported about water safety and that there were 68 drownings in the Couty last year and that is about average year after year. This is the leading cause in death in children

from one to four in age. This topic affects all races, income levels, and genders equally. This tragedy is avoidable by proper supervision of children, fencing around pools with alarms, proper lessons, and no alcohol with water activities, These practices can reduce the number of drownings in our pools, lakes, rivers, and bathtubs.

There are resources to connect renters to resources facing eviction. It was implemented last week and now Spanish speakers will be able to connect to their government. Sherman Oaks Neighborhood Council Movies in the Park August 26<sup>th</sup> Event starts at 6:00PM and the movie starts at 8:00PM. The movie will be Super Mario Brothers and there will be free treats and this will be the last movie for the year.
- e. Council District 6 President Schreiner introduced Councilwoman Imelda Padilla. She reported that it was very important to be at the meeting and that she would stay and listen for about an hour. It will take a few more weeks until they fill the field deputy position for the Van Nuys area. Mr. Hendry informed Ms. Padilla about a historic copy of the City seal on a private property that might be able to be saved.
