**3.** Discussion and possible action to approve an NPG of \$4,365.28 for **Meals in Motion** to cover the costs of food and materials for 8 free Family Cooking Night events (2 per month through June) to be held at Valley Presbyterian Hospital for up to 15 families per session.

Low-income residents of Van Nuys will be targeted in outreach for the events. Each family will cook a meal, which they will eat together at the event – plus 2 more meals that they can take home for future dinners. Assuming 4 members per family, each event will serve 15x4=60 individuals; the 8 events will serve 8x60=480 individuals.

4. Discussion and possible action to recommend that the Board approve a payment of up to \$679.50 to City of LA Publishing Services to purchase business cards for up to 18 VNNC members (priced at \$35.50 per box of 200 cards), plus pay a March 2020 invoice of \$40.50 (for a box of cards ordered for former Board member Richard Marks) that was never paid.

<u>Background:</u> At the September 13, 2023 meeting of the VNNC, a motion was approved to spend up to \$400 to purchase business cards and name tags for current Board members. On the recommendation of Terrence Gomes, David Harari and David Kopelev contacted Abby Truong of City of LA Publishing Services to inquire about the cost for business cards that would include the City Seal in color. Ms. Truong advised that the City's price for a box of 200 business cards with two-color City seal would be \$35.50. However, she informed us that the VNNC had an unpaid invoice from March 20, 2020 of \$40.50 for a box of business cards ordered for former Board member Richard Marks. (The link below connects to a copy of the unpaid invoice.) Ms. Truong said that the VNNC would need to agree to pay the outstanding invoice at the same time as it paid for a new order of business cards.

Given the quote of \$35.50 per box of business cards, we realized that the amount authorized by the Board in September would not be adequate to pay for business cards for 15 current Board members. The proposed motion will replace the September motion. It is proposed that this motion authorize purchase of up to 18 sets of business cards, in order to allow us to order cards for any new Board members who are appointed today and in the next few months.

5. Discussion and possible action to recommend that the Board advise DONE that the VNNC wants to retain the current two Zoom licenses assigned to the VNNC and to pay the City \$400 for the licenses (at \$200 per license); and that the licenses be assigned to the VNNC President and Vice President.

<u>Background:</u> When Neighborhood Councils were required at the beginning of the COVID-19 pandemic to conduct meetings virtually on Zoom, DONE provided each Neighborhood Council with one Zoom software license. The license was assigned to the VNNC President. When the Neighborhood Councils had only one license, the President was required to set up and open every Zoom meeting. Later DONE gave Neighborhood Councils the opportunity to purchase additional Zoom licenses for \$200 each. The VNNC initially authorized the purchase of two more licenses, but ultimately only one more Zoom license was purchased and assigned to the Vice President at that time (Kathy Schreiner).

On February 5, 2024, the President received the following request from NEA Alfonso Manzo:

We ask that you share with us [DONE] both if you will be using Zoom as well as how many licenses your Neighborhood Council plans on purchasing. Please note that each Zoom account will cost approximately \$200, maintaining the pricing structure established at the outset. Opting for licenses through the department's account presents a cost-effective alternative compared to direct purchases from Zoom.

On the assumption that the VNNC will ultimately be able to vote to make use of SB 411 to hold some meetings virtually, it is recommended that two licenses be retained and that the licenses be assigned to the current President (Kathy Schreiner) and Vice President (Maduka Nkuku).

The **Applicant**, Astgik Harutyunyan, plans to demolish a current single-family house, with detached garage, for the purpose of constructing a one-story child care facility for 99 children, ages 18 months to 6 years. Since 2013, the applicant has operated a similar licensed child care facility called "Little Stars Academy Preschool" located at 14237 Van Nuys Blvd, Arleta. 91331.

<u>Background:</u> On February 7, 2024, Lamont Cobb, Planning Director for Councilmember Imelda Padilla CD 6 sent an email to the VNNC President stating the following: "I am reaching out to seek your support for an important initiative that promises to significantly enhance mobility, safety, and accessibility in the Sepulveda Basin area – the Sepulveda Basin GAMES Legacy Project.

In partnership with Metro, the City is applying for a U.S. Department of Transportation RAISE Grant to fund a comprehensive package of improvements. These enhancements, identified as community priorities in the Sepulveda Basin Vision Plan, include the development of a new Balboa Mobility Hub, the introduction of new signalized crosswalks, the creation of a pedestrian gateway, the redesign of the G Line Pathway, and safety and access improvements along Haskell Ave and Balboa Ave.

The project is poised to transform the Sepulveda Basin into a more accessible, safe, and connected space for pedestrians, cyclists, and transit users, fostering greater connectivity to the many amenities within its 2000 acres. The City is requesting \$25 million from the federal government to bring this vision to life. The Sepulveda Basin is an important asset to our community, and these improvements will make it more accessible to Van Nuys as well.

Councilmember Padilla hopes to work with all stakeholders as we look to refine and build out a bold vision for the Basin. Your letter of support is crucial to demonstrating the strong community and regional demand for this federal investment. Such support will be instrumental in securing the necessary funding to make these much-needed improvements a reality."

## **10.** Reminder/discussion about Bylaws requirements regarding attendance at Board and Committee meetings in order to maintain eligibility as a Board member.

VNNC Bylaws Article V Governing Board

Section 5 Duties and Powers:

... Each Director [Board member] is required to be an active participating member of at least one (1) official Board Committee.

Section 7: Absences:

Any Director who misses three (3) unexcused consecutive Regular Board Meetings in any six (6) month period may be subject to removal by majority vote of the Board.

Absences for all Directors shall be recorded in the VNNC's meeting minutes or other manner of Council record keeping. Upon missing the stated number of board meetings, the President shall notify the Director of his/her absences and place the removal of the Director on the agenda of the next General or Special Board meeting, scheduled and noticed as per the Brown Act, whereupon the Board shall determine the validity of the absences before taking action to remove the Director.

# 11. Discussion and possible action to implement two new VNNC Committees approved at the January 10, 2023 Board meeting by appointing chairs and identifying possible issues for early exploration.

a. Public Safety, Human Services, and Animal Welfare Committee.

This committee will consider issues and action items that can enhance personal safety of residents, safety of neighborhoods, support for local police, support for City initiatives to help people move from living on the streets into interim housing (including Inside Safe, Circle, and Council Office activities), and support activities to improve the welfare of feral animals.

Example of potential issues/activities to consider:

- Coordinate with Council offices and Circle staff to support cleanups and special help for unhoused individuals.
- Explore a possible NPG to aid pets of unhoused individuals.
- b. Parks, Public Spaces, and Sustainability Committee

This committee will consider issues and action items that can improve the cleanliness and visual environment in Van Nuys, encourage greater use of reporting through 311, increase open space, enhance the tree canopy, and support initiatives to preserve and increase natural resources (such as native plants, groundwater storage, etc.) and address climate change.

Example of potential issues/activities to consider:

- Research cost and feasibility of funding a more visible sign identifying the location of the Van Nuys Branch Library and its parking lot.
- Research cost and feasibility of posting a display box outside the Braude Center for posting of agendas and other community information.
