- a. **Homelessness:** The 2023 Greater Los Angeles Homeless Count results estimated 46,260 people experience homelessness on any given night in the City of Los Angeles. The issue of homelessness and its associated challenges have been on the minds of the city and our stakeholders for years. So, it is no surprise that the most submitted questions for tonight's forum centered on homelessness, with concerns raised specifically about encampments, people living in cars or RVs, and the need for clean parks and sidewalks. *What is your plan to address homelessness and the additional concerns cited*?

## **Guidelines**

A neighborhood council member who is involved in a campaign should not be involved in any way in planning or participating in the candidate forum.

A neighborhood council may not mail (via U.S. mail) more than 200 invitations or flyers referencing any candidate. A neighborhood council may mail a meeting agenda to individuals on its mailing list for agendas, however.

The format of a candidate forum plays a significant role in ensuring that it remains non-partisan and that candidates are treated fairly and equally.

The neighborhood councils cannot do anything that would show preference for one candidate over another.

All certified candidates have been invited with sufficient notice to this candidate forum.

If requested, interpreters will be provided. Closed captioning will also be enabled.

The order of speaking has been determined randomly and will shift each round.

Each candidate is permitted to have video and audio enabled for the Zoom forum.

Be clear about time limits with candidates before the event starts and stick strictly to the limits so no one gets shortchanged.

The chosen moderator is unbiased and will ask the same question to all candidates, using the same wording for each candidate.

Each candidate will be asked the same number of questions and given the same amount of time to respond.

Questions have been provided in advance.
