Public comment is limited to a maximum of 2 minutes per speaker per item with a maximum of 10 minutes total per meeting, unless adjusted by the presiding officer of the Board. **Actual time for each comment will be recorded in 30 second increments (i.e., 30 sec., 1 min., 90 sec., 2 min.).**

**Speakers shall limit their comments to matters relevant to the item on the agenda. The Chair may rule that the speaker is out of order if the comments are not germane to the item under consideration. Speakers shall direct their comments to the Board (not to an individual).**

Invitation extended by Julie Leyba, Manager of Government & Community Relations of NEVHC, reads as follows: “The NEVHC is a nonprofit community health center providing primary, dental, and behavioral health services for medically underserved populations throughout the San Fernando and Santa Clarita Valleys. We operate 18 health centers that serve over 82,000 patients annually. This year, we plan to host a **Community Resource Day on Saturday, September 7<sup>th</sup> at Van Nuys City Hall** from 10 AM – 2 PM with special collaboration with Councilmember Imelda Padilla. The purpose of the event is to bring community partners to bring resources for the community with a special focus on promoting civic engagements.

“NEVHC recently received a civic engagement grant through the California Primary Care Association to promote nonpartisan voter education for 2024. We want this event to be fun and resourceful, but educational and empowering for our residents of the valley to participate in the voting process! We would be thrilled to have Van Nuys Neighborhood Council table at the event.”
