These meals provide essential nutrition to seniors who face barriers to accessing food due to mobility limitations, chronic health conditions, or financial hardship.

This investment directly addresses food insecurity among older adults while also reducing social isolation through consistent wellness checks during delivery. 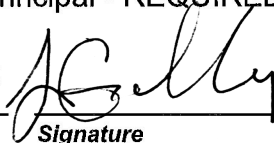

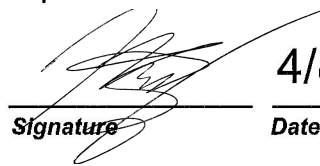
